

CONDITIONS OF SALES

ORDERS: All orders regarding our products will be considered accepted at our general conditions of sale. Any exceptions will be considered valid only if confirmed in writing by Freud S.p.A. - Società Unipersonale. Even if accepted through our sales personnel, orders are subordinate to our acceptance. The issue and dispatch of the order confirmation ratifies our formal acceptance of the order and the insertion of the material in our production and/or delivery cycles. Orders cannot be changed, varied or cancelled, not even in part, unless otherwise accepted by Freud S.p.A. - Società Unipersonale. Should the Customer's solvency be lacking, Freud S.p.A. - Società Unipersonale reserves the unchallengeable right to cancel the order or to postpone delivery of the material concerned.

PRICES: The prices indicated on the Freud price lists are fixed and invariable, "ex-works", excluding VAT, at net of packaging costs. The final prices are determined on the basis of the Freud price lists, discounts or net prices in force at the moment of delivery. The VAT rate shall be the one in force at the moment of delivery.

DELIVERY: The delivery terms indicated on the order confirmation are only an indication. Failure to respect said terms shall not prejudice the validity of the order, nor shall it constitute a reason for cancellation or a request for the payment of a fine and/or damages.

CARRIAGE: Goods are delivered at the buyer's own risk even if Freud S.p.A. - Società Unipersonale chooses a preferential courier or in case of goods consigned free at destination. Freud S.p.A. - Società Unipersonale claims no responsibility for goods that are damaged in transit, broken, stolen or tampered with.

DELIVERY TERMS: If shipment prepaid, we will debit freight charges for the same amount as paid by Freud to the service provider.

PACKAGING: A contribution of 0,7% of GOODS' value will be charged for packaging expenses. Freud will take care of packaging the goods in the best possible way to prevent damages during transportation.

PAYMENT: Payment shall be made directly to Freud S.p.A. - Società Unipersonale – Pavia di Udine (UD) ITALY. Rounding off or arbitrary deductions are not allowed.

WITHDRAWAL FROM THE CONTRACT: The buyer may withdraw from the contract, except where the goods have been clearly personalized. Withdrawal shall be formalized by writing a notice to

WARRANTY: all the tools are designed and manufactured according to meticulous procedures and are guaranteed without manufacturing defects. The products are covered by a warranty period of 18 months, from the date of purchase as per relevant purchase receipt.

The following cases are not covered by the warranty:

- modified or integrated tools (by way of example and not exhaustive: with welding, tip brazing, re-sharpening, re-balancing works, bore modification and in general everything that may change the original characteristics of the tool.
- parts of the tool subject to natural wear or deterioration due to proper use and defects of the tool attributable to the same causes.
- defects of the tool attributable to non-observance of the instructions for use; improper use; improper assembly; applications other than the original; conservation in abnormal environmental conditions; lack of general maintenance and care.
- defects of the tool caused by the use of non-original accessories, complements and spare parts.
- Minor anomalies of the product characteristics that do not invalidate the value and the performance of the tool
- accidental damages caused by the customer himself.

We claim no responsibility for direct and indirect damages due to an improper use of the product or inobservance of the provisions and conditions of use indicated on the tools, manuals and catalogues.

The competent court for any disputes which may arise is the judicial authority of Milan.

Our company will do its utmost to provide the correct descriptions, designs and any other information in our correspondence, catalogues etc., but Freud S.p.A. - Società Unipersonale claims no responsibility for any imprecision in the above-mentioned documents.

OWNERSHIP RIGHTS: All rights are reserved in compliance with the law. Freud S.p.A. - Società Unipersonale prohibits copying or reproduction of text, designs or illustrations, in all or in part, without written consent of the undersigned. The Freud trademark is regularly registered and protected. We reserve the right, from this moment on, to safeguard our interests in relations to any infringement in Italy or abroad.
